

**MINUTES OF THE SPECIAL MEETING  
OF THE TUSCARORA TOWNSHIP BOARD

**June 24, 2020**

Meeting called to order at 6:35 p.m. by Supervisor Ridley.

Roll call by Clerk Sue Fisher. Board members present were Mike Ridley Supervisor; Sue Fisher, Clerk; Bobbi Balazovic, Treasurer; and Trustee, Janet Vance. A quorum of the board was present.

Supervisor Ridley opened the Budget Public Hearing for Fiscal Year 2020/2021 at 6:40 p.m. Questions on the General Budget: What is the millage for the General Budget? Do the trailer parks pay taxes? Is the Revenue Share reflected here? What was reduced? How does this budget compare with the budget workshop? How are we doing with the State Park? Is there a fund balance for the sewer? How long is the State Park contract? Did we renegotiate? How much is allocated for education? Why does ticket fines go to the County? Ordinance violations go to libraries. What is community promotion? Supervisor Ridley closed the Public hearing at 7:20 p.m.

Balazovic moved and Vance supported the budget adjustment and fund transfers as presented: \$5,641 from 590-000-003-01 Sewer RRI Account to 590-000-003-00 Sewer O & M account and \$20,000 from 207-000-375-00 Police Fund Balance to 207-301-702-00 Wages.
